Rental Informations

All prices are include 100 free kilometers per day with at least liability insurance at a value of 5 million Euros (more informations at the point: insurance). Comprehensive insurance with excess (CDW) and motor vehicle - Theft insurance with Excess can be completed (see Liability Reduction -- Fully comprehensive insurance). All prices are in Euros including IVA / VAT. The tenant has for all involved in the operation vehicle costs (including fueling, the garage, the use Tolloed of Roads - Vignette, etc.) pay for itself.

Contract: The tenant signs a written contract with the landlord. As a rental periods apply from 8:00 a.m. to 6:00 p.m. (each day). Beyond the additional day will be a respective rates.

Transfer: The handover of the vehicle is in our rental station Merano. A hotel service is possible by payment of a fee (see hotel service). The vehicle is handed over to any Damage from you to review. In that case a handover protocol created by the tenants and Landlord is to sign. Repairs on the vehicle may be made only with the consent of the Landlord to be carried out. Navigation systems, child seats, etc., can be the landlord against Payment of a fee on request.

Age of the driver: Minimum age is 21 years.

Driver's license: The driver must be min. 2 years in possession of a valid driving license of Class 3 or Class B (Euro-norm) that he in the original and in conjunction with a valid passport or Identity when signing the contract must submit.

Deposit: The tenant has to deposit a bail. The height of the deposit is for:
Mini Cooper Cabrio = € 2300, Economy Cars = € 1400, City Cars =€ 1200
The deposit is paid by credit card (Visa and MasterCard credit cards on the driver's name). All prepaid cards, debit cards are not accepted.

Driver under 23 years: The conclusion of CDW is a prerequisite for renting a vehicle to persons under 23 years. In addition, we calculate in this case a risk premium of € 10 per day, maximum for 10 days.

Additional driver: To use the rental car is the only person entitled to the contract listed. Will the vehicle used by several people, we charge per day per driver Administration fee of € 10 (maximum of € 50 per rental and driver).

Tank system: The tenant is obligated to the rented vehicle with at least the same tank contents abeyance, with whom he has accepted it, otherwise it will be fun to rent a Fixed amount of € 60 for cars and € 12 for scooters into account. The Replacement costs for any given fuel by the lessee from FunCar is excluded.

Entry rules: To drive with the car or scooter outside of Italy, Austria or Germany is not permitted. Exceptions are to be agreed in writing. Deadweight of the vehicle on Ferry is not allowed, except for Sicily, Sardinia and Elba and Ischia.

Hotel delivery / collection: On request and against a payment (within the City of Bolzano or Merano) of € 25 and outside the citys of € 1.80 per Kilometers (min. 30 kilometers will be calculated).

Liability insurance: The rental price includes a car-insurance for persons and property at a value of € 5 million Euro. Not insured by liability insurance are damages to the rental vehicle itself (these damages are limited only by the comprehensive insurance).

The insurance is especially for disturbances of consciousness of the driver by Alcohol, medication or drugs. After the occurrence of an insurance case, the insured person committed to the damage immediately, but no later than the next day, the insurance or the landlord to report. A Insurance certificate is enclosed with the documents.

Liability Reduction - Comprehensive Insurance:

The conclusion of a comprehensive insurance to cover damage to the car and with an excess of the agreed contract amount is possible. The liability reduction applies to all damages including vehicle theft (CDW). The cost of this liability reduction Comprehensive insurance) amounted to € 12/day (Mini Cooper Cabrio = €18/day). Should they be involved in an accident or is otherwise damaged or to a theft of her car, the landlord retains the security lodged in height, in Comprehensive coverage of the

damage to their rental car is not replaced. Also not covered by the Comprehensive insurance to replace damage to tires, glass, roof and underbody / oil sump.

Vehicles unpaved roads is prohibited and is not insured.

Please note that reducing the liability does not occur when an incident the police have not been consulted or was the vehicle of a person not licensed has been left (see our Terms).

The following events are caused by the damage insurance does not cover:

- by the general disregard of the Auto Terms Less or damages; this applies particularly to the banned travel unpaved roads
- by drunk driving, or grossly negligent act damages
- Loss or damage to the car key
- Damage to the underbody / oil sump
- Private items stolen from the car is stolen or damaged in an accident have been
- Consequential costs such as towing, hotel accommodation, telephone etc.

In case of a damage, the following points must be observed:

- Immediately notify the landlord
 - Participation in an accident opponent to call the police and a police report take up
 - When returning the vehicle of the landlord to issue and sign leave a damage report
- We note that a refund of the deposit will be refused if the Insurance (partial or full) the main damage is not regulated.

Additional Insurance: You can add additional insurance such as a Personal Accident insurance. The fees is to be seen from the tariffs of the landlord.

Cancellation fees: Cancellations must be made in writing either directly to the landlord. The cancellation fees are as follows: until 3 days before reserved time of renting € 50 In the case that the vehicle is not fetched, beside the renting payment a handling charge is raised from €50.

Traffic information about Italy (Abstract / without warranty)

- There is a vest (signal jacket) in the vehicle (in the case of a breakdown on the road or on the road edge, it must be worn). You should bear Certification EN 471.
- On the Italian roads outside built-up areas must be on the highways also headlights during the day thereafter.
- Maximum speed for vehicles under 3.5 tonnes:
Highway 130 - in fog, rain or snow - 110 km / h
Highway 110 - in fog, rain or snow - 90 km / h
outside built-up areas 90 km / h
within built-up areas 50 km / h
For three-highways when expressly allowed by traffic sign, up to 150 km / h
- There is also in Italy, the full duty belt and helmet for Motorcyclists; - The blood alcohol limit is 0.5;
- Telephoning in Italy during the trip without handsfree prohibited.
- It is prohibited to a reserve canister with you.

In addition, the conditions of the tenancy agreement.
The contract with the landlord is subject to Italian law.
